"An Act To Setup and Structure the Department of Security" Republic for the United States of America

"Grateful to Almighty God for our Freedom", be it resolved and re-inhabited by the Senate and House of Representatives of the Republic for the United States of America to establish the American Security Act. The purpose of this Act is to setup and structure the Department of Security for the Republic for the United States of America (Republic). This Act may be cited as "An Act to Setup and Structure the Department of Security" a.k.a. "American Security Act."

Section 1: Be it enacted by the Senate and House of Representatives of the Republic for the United States of America in Congress assembled, the Department of Security is hereby created. This department shall provide enforcement for the rights of We the People as guaranteed by the Constitution of the United States of America and the Bill of Rights.

Section 2: and be it further enacted, the "Secretary of Security" shall be the director of said Department.

Section 3: and be it further enacted, the Secretary of Security shall be granted the authority by Congress to establish the American Rangers within the Department of Security.

Section 4: and be it further enacted, the Secretary of Security shall be responsible to include all functions of management and develop detailed policy and procedure directives for the American Rangers.

Section 5: and be it further enacted, the primary responsibility of the American Rangers is to protect the properties of We the People and their unalienable God given Rights.

Section 6: and be it further enacted, to apply for membership in the American Rangers, candidates shall be at least 21 years of age and a documented Citizen of the Republic for the United States of America.

Section 7: and be it further enacted, the American Rangers shall also provide security and protection for the President of the Republic, Cabinet members, and members of Congress.

Section 8: and be it further enacted, that all American Rangers shall take an oath of office or affirmation to protect, preserve, support and defend the Constitution of the United States of America from all enemies foreign and domestic.

"An Act To Setup and Structure the Department of Security" Republic for the United States of America

Section 9: and be it further enacted, that the Governors of the Free States may call upon the services of the American Rangers in times of need. The Secretary of Security shall make available uniformity in the training of State Rangers upon request of the several States.

Section 10: and be it further enacted, that We the People, having supreme authority, may at time of need call upon the services of the American Rangers.

Section 11: and be it further enacted, the American Rangers may pursue beyond the borders of the Republic to retrieve a fugitive and/or return property stolen from We the People.

Section 12: and be it further enacted, American Rangers shall be charged with serving and keeping the peace within the borders of the Republic and in places authorized by treaty and/or other positive law.

Section 13: and be it further enacted, that all officers and other public servants within the Department of Security shall for service, receive from time to time and in amount and form determined by Congress, compensation in money and/or other form.

Section 14: and be it further enacted, Congress shall review the American Rangers and renew, modify or terminate on an annual basis. The American Ranger Program will expire in thirty-six months if not renewed or modified.
