#### An Act of 2012 to Further Amend

An Act to Accept and Restructure the Treasury Department of 20120423

## Create the Office of the Commissioner of the Revenue

The People of the Republic for the United States of America in Congress Assembled present this Act:

#### **Section I: Purpose and Title**

The purpose of this act is to further amend *An Act to Accept and Restructure the Treasury Department of 20120423*, by creating the Office of the Commissioner of the Revenue. This Act may be cited as *An Act to Create the Office of the Commissioner of the Revenue of 2012*.

# <u>Section II – Abolish the Office of Assistant to the Secretary of the Treasury and create the Office of the Commissioner of the Revenue:</u>

Whereas, The Assistant to the Secretary of the Treasury position was created in An Act to Establish the Treasury of 1789 and continued in An Act to Accept and Restructure the Treasury Department of 20120423; and

*Whereas*, The re-inhabited Republic for the United States of America requires a Commissioner of the Revenue to receive revenues into the Republic Treasury;

Therefore, Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the present office of Assistant to the Secretary of the Treasury, be abolished, and that instead thereof there be an officer in the Republic Treasury, to be denominated Commissioner of the Revenue, who shall be charged with superintending the collection of the revenues of the United States, and shall execute such other services, being conformable to the constitution of the department, as shall be directed by the Secretary of the Treasury.

Updates to *An Act to Accept and Restructure the Treasury Department of 20120423* sections are shown below, substituting the Assistant to the Secretary of the Treasury with "Commissioner of the Revenue".

**Section 1.** *And be it further enacted*, That there shall be a Department of Treasury called the Republic Treasury, in which shall be the following officers, namely: a Secretary of the Treasury, to be deemed head of the department; a Comptroller, an Auditor, a Treasurer, a Register, and a Commissioner of the Revenue.

**Section 7.** *And be it further enacted*, That whenever the Secretary shall be removed from office by the President of the United States, or in any other case of vacancy in the office of Secretary, the Commissioner of the Revenue shall, during the vacancy, have the charge and custody of the records, books, and papers appertaining to the said office.

Addition of new Section 10 to define the Commissioner of the Revenue:

**Section 10.** *And be it further enacted*, That it shall be the duty of Commissioner of the Revenue, to be charged with superintending the collection of the revenues of the United States, and shall execute such other services, being conformable to the constitution of the department, as shall be directed by the Secretary of the Treasury.
