We love our fellow man, America, its People and the Republic for which our flag stands. We observe the greatest commandment, namely, that we love God and Love our fellow man. We believe that the rule of law should be applied justly and equally to all, both small and great without regard to race, gender, color, financial status, handicap, or religious affiliation. There are those in our midst who want to question the legitimacy of my Presidency. The details of how I became President of the Republic for the united States of America are documented in Volume 2 of *Re-Inhabited*, "*The Story of the Re-inhabitation*" by Jean and David Hertler. That being said, let me get into more of the Lawful aspects of my Presidency. To do this I must first address the Presidency of James Timothy Turner. He was elected President via a voice vote on a nation-wide phone call. This was done prior to the adoption of what we refer to as the Utah Document (*Declaration of Sovereign Intent*) in which the American People chose to re-adopt the *Constitution for the united States of America* as our law form.

In hindsight, what should have happened after the adoption of the *Constitution for the united States of America* would have been to hold a Presidential Election in order to comply with that law form. Due to the excitement and business of the time this was never brought up until after when then President Turner was kidnapped by the U.S. Corporation. As part of the take down of then President Turner they also had agents in our midst who strongly encouraged the American People to no longer participate in their civic duties in regard to finishing the job they started, standing up the original *de jure* Republic.

**In addition**, threats were made that everyone continuing to hold office in the Republic would be arrested and face similar circumstances as then President Turner. At this point in time the majority of the Republic Office Holders either resigned or became dormant. One of those who could not be reached was the Republic Vice President; some evidence suggests that he fled the country. This meant that the burden of the Presidency fell upon my shoulders since I was the President *pro tempore* of the Republic Senate.

**As Acting President** I had to make the decision of whether we were going to continue to stand, as a remnant, or we were going to disband and abandon everything we had accomplished. This was a situation that I never thought I would be faced with. My decision: we would not give up, we would continue the good fight; no matter what, we were going to Restore the Republic that our Fore Fathers had intended to pass down to their posterity.

**Our first focus** while I was Acting President was to help then President Turner as best we could in his court fight. Both he and ourselves were not successful in that regard. Please read "James Timothy Turner, An American President Political Prisoner" by Jean Hertler to garner the details of that situation. Once the dust had settled from dealing with his court case it finally occurred to us, highlighted by the fact that I was only the Acting President, and not

the President was that we were going to need to comply with the *Constitution for the united States of America* and have a Presidential election.

**At this point** it became my duty to have the Secretary of State post in a national newspaper about said Presidential election. I placed my name in the hat as one of the candidates, with the hope that someone else would win. I have never been one who ever wanted to be the center of attention and, if I had my preference, will always prefer to be in a supporting position, not the one out front. Maybe that will help you understand why I was in hopes that someone else would win the election.

The concern that I had at the time was: were the several states, a remnant of thirteen, the same number as our Fore Fathers started off with, going to follow through with all the details required by the *Constitution for the united States of America* in order to elect a *de jure* Constitutional President for the interim government? Were they going to do all of the travel and paperwork required to document a Presidential election which included proceeding with the Electoral College procedure. What I found out was Yes, they were; they performed all of the necessary steps required by the Constitution and held a Constitutional Presidential Election in which I won the majority of the electoral votes and won the election. What was the next step? We had to hold a Presidential Inauguration. Most of these details are documented in *Volume 2* of *Re-Inhabited*, "*The Story of the Re-inhabitation*" by Jean and David Hertler.

**Back to the point I was making above.** The Presidency of James Timothy Turner was a precursor to that of my presidency. His presidency can best be described as "President of the National Assemby" or "President of the Second Constitutional Convention" being that he was not elected in accordance with the Constitution for the united States of America, but before it's re-adoption in Utah by the American People. Had we had a better understanding of our adopted law form and had he not have been kidnapped by the *de facto* U.S. Corporation I have no doubt that he would have been able to win the Presidential election in which I was a candidate. I also know that I would not have chosen to have been a candidate in any such election in which he was running.

**The other thing** the reader should consider is the raw courage and fortitude of those of us who remained faithful to the cause after the arrest of Tim Turner. It would have been much easier to just fade away never to be heard from again. So, in essence, it has been somewhat of a miracle that this remnant of the American People have been able to continue this race while still holding onto the torch of liberty.

**So, where does that leave us** as far as Lawful Standing? First of all, since the U.S. Corporation interfered with the American People who were and are simply carrying out our civic duty to be self-governing, the very fact that they intervened and arrested then President Turner actually gives those of us who remained steadfast in the cause of Liberty greater standing in law. Even though we were a remnant and no longer had a quorum of free States we were able to function as an interim government and seat a lawful President for the Republic for the united States of America. Why did I say "President for the Republic for the united States of America" and not "President of the UNITED STATES OF AMERICA" you might ask? Because we are not claiming to represent all Americans; but as far as our standing as the *Lawful Civil Authority* upon the land, we do claim that. We are holding *de jure* seats on behalf of the American People until such time as they are awakened to the fact that they need to be self-governing once again.

**And, now** that we have a Constitutionally elected President of the interim government, the *Republic* for the united States of America, we are able to re-seat the several States which, in law, have been vacated and in the condition of being territories, by using the method that our Fore Fathers gave us: the *Northwest Ordinance*; codified by the first *de jure* congress it became known as *1 Statute 50*. <u>Implementation of the Northwest Ordinance</u> and <u>Addendum to "Implementation of the Northwest Ordinance"</u> The next *de jure* Presidential election will be scheduled once the *de jure* free States are stood up and are no longer vacated territories in status. That depends on how fast we, working together, can garner at least 30,000 electors in each of the free states and hold elections for *de jure*, not appointed, officers that are mandated by newly ratified free State Constitutions that would have been ratified by at least 30,000 electors in said states.

**If we are stood up** prior to the above happening then the above will still need to take place prior to the next *de jure* Presidential Election during the transition period. Remember, we are the interim government and our seats are held until such time as we can be replaced by those for whom we are holding seats.

**If you are an office holder** or candidate for an appointed office, and if for some reason, you are not willing to accept the validity of my Presidency, as outlined above I ask for your immediate resignation.
