

# Republic For the United States of America

**The Re-inhabited Republic is not** just another Patriot movement, but serves *We the People* standing-up the legitimate government in America as established in 1776 under our Constitution, giving power to the People. As today's lawful, interim government it provides the means for a transition back to Constitutional Governance as intended by our Founding Fathers. Today, our battle is similar to that of our Founding Fathers.



## The USA Corporation

The Constitutional Republic was abandoned during the Civil War yet could not be lawfully destroyed (see sidebar). Instead, it was subverted by an imposter, corporate government. Our Republic was infiltrated such that States, all Courts, administrative agencies, at least some law enforcement and Departments of the

Military are structured as for-profit corporations as are most cities, towns and other local municipalities. Congressmen and Senators' oaths are to the Corporation, not to the People, instituting unlawful Mandates and Executive Orders. Unlawful (corporate) elections were held in several States with a concerted effort to deceive the American People to give up their inalienable rights. For decades, corporate interests were furthered through trusted media sources, Churches and our educational system as propaganda, diverting truth and knowledge. State Citizens were transitioned to residents with their unalienable rights being replaced with privileges through the use of contracts. Americans are now dealing with despotism that is destroying both the American way of life and the American People—a deep state has caused harm, both to America and nations around the world.

## Waking the Republic vs Corporation

Today, the United States *de jure* government (the Republic) and its corporate, *de facto* government operate side by side, each performing their designated functions. Decades of filtered information and lack of transparency is a great deception for the American People. The United States corporate structure has amplified propaganda with programs, incentives and systems with threats of force to perpetuate a new normal of division and opposition throughout the country. Cultural amnesia has descended upon the American People. Today, the American People largely do not know their true sovereignty under the constitution, nor the authority it bestows upon them. It's past time to awaken We the People and collectively, *reset* America.

## Reseating the Republic



The Republic for the United States of America is the lawful interim government for the American people; a government in waiting, parallel to the U.S. Corporation.

In 2010, a group of courageous Americans took lawful action to re-inhabit our Republic. Electing delegates from the free States who were not civil officers, a quorum created the 1st Congressional Assembly for the Republic of the United States *for* America and, lawfully reclaimed the American Republic on behalf of the

American People. Public notice by warrant was then delivered to the fifty corporate State governors who declined and refused to reoccupy the vacated Republic. This allowed the American People to lawfully re-inhabit the positions of the original, Representative American Republic. Since November of 2010, the Republic for the United States of America has been the only lawful *de jure* government in America, in a provisional (interim) capacity.

## How We Lost Our Constitutional Republic

During the bloody Civil War, Abraham Lincoln instituted an “executive” government and vacated the Republican Legislative Congress to save the country. He was assassinated before it could be re-seated, abandoning, but not abolishing the Republic in 1871. During this vulnerable time, the Republic was infiltrated by ‘cunning, ambitious and unprincipled men’ who supplanted the original Constitution with crown and banking interests to re-structure the UNITED STATES, Inc. into a corporation -- a government foreign to the Constitution and outside of *due process* of Law. Motivated by corporate profit they took control of our monetary system and currency, promoted endless wars, onerous taxation, and replaced our inalienable rights with injustice in the courts and irresponsible fiscal management. Unlawful actions without the consent of the governed transformed a representative republic into democratic socialism.

## Recognizing the Republic

The UNITED STATES Corporation has been notified, as has the United Nations, International Court of Justice at the Hague, the Universal Postal Union and Joint Chiefs. One hundred and thirty two nations endorsed the Republic for the united States of America and supported what we did back in 2010. The Republic remains an interim and parallel structure with the de facto Corporate UNITED STATES until a majority of Americans embrace this, register with the Republic and lawful elections can be held.



## Actively Standing the Republic

Today, The Reinhabited Republic is the interim government and the lawful mechanism for the American People to step in and fill vacated seats of our *de jure* government temporarily as we transition back to Constitutional Governance. There are currently more than a quorum of Free States being seated in the *de jure* Republic with interim Governors, Senators, Representatives and Chief Justices. The Republic is today building the consent of the People (voters/electors) to hold free, fair and lawful elections as they register with the Republic (see link below). Until such time, The Republic for the United States of America has the lawful right to operate as a parallel, provisional government in America while the UNITED STATES municipal Corporation continues down the path of self-destruction.

## Power to the People

We invite all who love America to join together and restore the Republic to its' rightful glory. Americans have always embraced a deep-seated desire for our national purpose and destiny and we invite all Patriot groups and individuals to step in to reinhabit the Republic, following the link below. Once the People understand the truth that the Republic for the United States of America is the lawful civil authority for this country, we can peacefully reclaim our nation. Until such time as valid general elections can be held, appointment power is conferred upon the office of the President of the Interim Republic. Many have sworn an oath to defend our Constitution against foreign and domestic enemies, and seek to restore the lawful governance system under the Constitution and to prepare the People for a national election as well as State elections to complete the transition back to the Republic for which it stands.

## How to Restore the Republic

Americans today find themselves engaged in the same battle as that of our Founding Fathers. That is, to preserve liberty over tyranny. No longer do we have the luxury of sitting on the sidelines and letting others fight for our Liberty. Reinhabiting the Republic is a nation-wide initiative that welcomes all Americans and Patriotic groups to join in standing up the Republic. The interim Republic awaits the fall of the corporate government and stands ready to hold lawful elections to restore our representative government. Once we have 30,000 lawful voters in each State, in accordance with the provisions of the *Northwest Ordinance* of 1787, we can commence representative elections that are free from corporate corruption.
