# Republic for the united States of America

## Public Notice

**Be it known** that we are the Republic for the united States of America. Anyone who volunteers to join the Republic is agreeing to support and defend the Constitution for the United States and all other lawful documents that supported the reseating of this Republic in 2010. This includes the Declaration of Independence, the original organic Constitution, and the Northwest Ordinance, codified into law by *1 Statute 50*.

**Be it also known** that the Constitution and founding principles listed above are not up for debate. The *Declaration of Sovereign Intent* (2010) and *Proclamation of Claim and Interest* (2012) were filed in the international systems as a sacred covenant with the American People. We cannot break that covenant. If someone in the Republic thinks that the Constitution is wrong, or the Northwest Ordinance (*1 Stat 50*) is not applicable, then that individual is not compatible with serving as an interim official in the Republic.

**During the most recent situation of “sowing discord”** (January-February 2025), a few individuals in the Republic failed to follow the Constitution and founding principles or argued that they were not relevant. In addition, a few Senators decided to bypass Standing Rules for the Senate and declare a quorum where one did not exist. In order to take proper action, the President established a committee of experienced leaders representing all branches of government, to determine a path forward. Several actions were recommended and completed, because the Northwest Ordinance (*1 Stat 50*) gives the President the authority to appoint or remove appointees from office: *“all officers so appointed shall be commissioned by [the President]; and in all cases where the United States in Congress assembled, might, by the said ordinance, revoke any commission or remove from any office, the President is hereby declared to have the same powers of revocation and removal.”*

**Be it also known** that it is also unlawful to mix jurisdictions, such as *de jure* and *de facto*. Something called a “Judicial Notice” is circulating through email, but the email contains a disclaimer that clearly states “For Entertainment Purposes Only” and mixes Constitutional law with *de facto* U.S. codes and statutes, which have no standing in this Republic. In addition, a real “Judicial Notice” is used in the *de facto* courts to establish a KNOWN fact, such as the outcome of a Supreme Court case, in the process of a lawsuit or other action. It is completely inappropriate to use such a thing to make accusations in a lawful *de jure* Republic.

The People of the free States in Union do not now, nor have we ever supported any intent of overthrowing the UNITED STATES municipal corporation acting as a government. We are not “Sovereign Citizens” as defined by Homeland Security. We are peaceful, non-violent and advocate peaceful, non-violent methods to restore and maintain a lawful, constitutional republican form of governance. We would never advocate or take part in the kidnapping of, or violence against any public official; nor do we affiliate with any hate groups; nor would we participate in any terrorist attack against the U.S. corporate government or any public or private official. We love our fellow man, America, its People and the Republic for which our flag stands. We observe the greatest commandment, namely, that we love God and Love our fellow man. We believe that the rule of law should be applied justly and equally to all, both small and great without regard to race, gender, color, financial status, handicap, or religious affiliation. In short, we believe in treating our fellow man as we would like to be treated. We show tolerance and respect toward corporate law enforcement officers even when those officers, through lack of knowledge, may violate or infringe upon our un-a-lien-able guaranteed liberties. We are not tax protesters or the like. We believe in conducting our commerce and the business of Republic governance in the open, not in secret meetings. We hold that the People intend to research actual Law as well as applicable case Law. We intend on attending as many seminars, meetings and lectures as possible given by law professors, lawyers and the like in order to learn the proper interpretation of law. We are willing to assist any local, state or national leaders, such as presidents, governors, congressmen, senators or representatives in coming to a clearer understanding of their constitutional duties and obligations to the American People.

**Be it also known** that infiltration of the Republic by secret societies will not be tolerated. The warnings of Statesmen like John Adams, George Washington and John F. Kennedy, coupled with historical events like the *Morgan Affair* reveal a timeless truth: **secret societies and religious orders with divided loyalties are an abomination to constitutional governance**. To safeguard the Republic, Americans must never again allow secret societies to destroy our law form and re-establish an oligarchy. If we, as a People, do not address this issue then we are doomed to a repeat of history whereby “...cunning, ambitious, and unprincipled men will be able to subvert the Power of the People and to usurp for themselves the reins of Government; destroying afterwards the very engines which have lifted them to unjust dominion...” as President Washington warned.

**I submit this notice to the American People** and their lawfully seated sworn and functioning officials and members, in the hopes of clearing up the confusion and to protect the American People from this attack. It is vital at this point in time that we all work together as a team, abiding by our constitutional law form. We can no longer allow unlawfulness and dishonor to fester in our midst.

**In closing, let me restate from a previous notice**

“that we have a Constitutionally elected President of the interim government, the *Republic for the united States of America*, we are able to re-seat the several States which, in law, have been vacated and in the condition of being territories, by using the method that our Fore Fathers gave us: the *Northwest Ordinance*; codified by the first *de jure* congress it became known as *1 Statute 50*. **The next *de jure* Presidential election** will be scheduled once the *de jure* free States are stood up and are no longer vacated territories in status. That depends on how fast we, working together, can garner at least 30,000 electors in each of the free states and hold elections for *de jure*, not appointed, officers that are mandated by newly ratified free State Constitutions that would have been ratified by at least 30,000 electors in said states.

**If we are stood up** prior to the above happening then the above will still need to take place prior to the next *de jure* Presidential Election during the transition period. Remember, we are the interim government and our seats are held until such time as we can be replaced by those for whom we are holding seats.”

**We must remain steadfast and united** in our shared mission to restore the Republic which was founded upon our Forefathers’ *Appeal to Heaven*. The enemy would not attack us now unless we were really close to the finish line. Let us stay resolute, diligently working to settle our states while remaining true to our oaths of office. I appreciate your dedication and perseverance and I am deeply grateful for all that you are doing.
