Official Response to SG Anon's Podcast

To the Esteemed Statesmen of the Republic for the United States of America

This document serves as the official response of the Republic for the united States of America to the video recorded by SG Anon on March 10, 2025, and published on March 12, 2025.

Introduction

For over 227 years, as George Washington cautioned in his 1796 Farewell Address, "cunning, ambitious, and unprincipled men" have subverted the sovereignty of the American People (Yale Law School Avalon Project). Our constitutional Republic—intended to be "of the People, by the People, for the People"—was covertly transformed into a corporate democracy without consent. In 2010, loyal Americans lawfully re-inhabited this Republic through the Declaration of Sovereign Intent and Proclamation of Claim and Interest (2012), grounded in the Constitution and affirmed by *Chisholm v. Georgia* (2 U.S. 419, 1793), which upholds the People as sovereign.

SG Anon's video distorts this mission with false statements, alleging historical betrayals, military conspiracies, and internal corruption. We reject these claims with evidence and lawful precedent, reaffirming our interim role to restore America's sovereignty and helping to free the world from despotic control. We invite patriots to discern the truth and join this noble cause.

Addressing SG Anon's Claims

After a meticulous review of SG Anon's video and its transcript, we address four central assertions:

1. The Republic's Foundation and Purpose

SG Anon begins with a historical review highlighting only a select few of our founding documents. However, his historical critiques are premature; only a fully restored Republic, after lawful elections have been held, can lawfully address such matters. His opinions do not alter this Republic's commitment.

The Republic for the united States of America is not a final solution but a lawful bridge to restore governance as it stood on December 19, 1860—the eve of South Carolina's secession, when Congressional seats began to be vacated. Our founding documents, filed internationally under customary law, preserve constitutional statutes up to that date unless nullified. Post-restoration of the Republic, the American People will be called upon to dismantle the corporate crime syndicate masquerading as our government. This will require many debates, committees, conventions, and elections—a monumental and potentially multigenerational task that must align with the Founders' intent (Constitution, Article IV, Section 4).

Unfortunately, SG Anon's narrative of American history aligns with others who are promoting independent "nation-states" within the borders of the United States of America. This occurs when someone claims that the Constitution (1789) is not the Supreme Law of the land, which means that the country reverts to the failed Articles of Confederation (1781). Claims of independent nations within U.S. borders align with Civil War secessionists, risking prosecution under the Insurrection Act of 1807 (10 U.S.C. §§ 251–255). Those supporting secession may, therefore, subject themselves to criminal liability, including prosecution for seditious conspiracy (18 U.S.C. § 2384), which carries severe penalties under federal law. This Republic fully supports the original Constitution and therefore will not support the concept of independent nation-states. We work diligently for the full restoration of the Constitutional Republic gifted to us by our Forefathers.

2. Re-inhabitation History

SG Anon's account of this Republic's "re-inhabitation" in 2010 relies heavily upon unverified hearsay. The authoritative historical record with over 3100 references is a two-volume series titled *Re-inhabited* by Jean and David Hertler. The books testify that James Timothy Turner was elected by state representatives in 2010 but served as an interim "Admin President." This status is very similar to having a "House Admin" or "Senate Admin" when either does not have a quorum to elect a House Speaker or Senate President, respectively. A full <u>Electoral College</u> confirmation for Turner was impractical in the early stages of the re-inhabitation. Following Turner's 2012 arrest by the FBI (<u>DOJ.gov</u>), his duties transitioned in line of succession to then Senate President *pro tempore* James Buchanan Geiger (Public-Notice-<u>RR950286699RUSA</u> – President of the Republic). President Geiger was elected in a Republic election with electoral college per the Constitution, in 2013. Due to the lack of a quorum since then, President Geiger has been oath-bound to continue his duties until a quorum can be established.

3. 1 Statute 50 (and The Northwest Ordinance)

SG Anon parrots a splinter group's assertion that the <u>Northwest Ordinance</u> (1787) invalidates the Republic. However, this Republic follows 1 Statute 50, which is the law enacted by the First Congress (<u>Journals of Congress, August 7, 1789</u>) to codify the Northwest Ordinance, and signed by President Washington. This "settled law" guided American statehood for over 120 years (<u>*Strader v. Graham*, 51 U.S. 82, 1851</u>).

After the infiltration of 2012-2013 caused several Republic seats to be vacated, then Senate President and then Vice President proposed the use of 1 Statute 50 to President Geiger to fill those seats. By April 7, 2014 (as confirmed by official Republic emails), Senate President sent an update to President Geiger on the status of the idea. On December 8, 2016, implementation of 1 Statute 50 was officially announced (2016 Implementation), after following proper Constitutional procedures through the House, the Senate, and the judiciary.

Additionally, SG Anon purports that Turner claims that he never approved of the use of 1 Statute 50. Although in prison during this time, Turner was fully briefed on the progress of the statute's implementation in the Republic. This included Turner's review and edits of the Re-inhabited books, which fully documented the efforts (*Re-inhabited*, Volume 2, and Hertler testimony). Even more puzzling is Turner's full support of the use of 1 Statute 50 while teaching the Re-inhabitation Plan in a video released on August 24, 2024 (<u>The Great American Hicks Show-episode-9-the-patriots-the-republic-the-plan</u>). Sometime after this, Turner suddenly and mysteriously reversed his thinking. In conclusion, his claims of sudden unilateral action by President Geiger to use 1 Statute 50 are baseless.

Lastly, there are Constitutionally mandated ways to repeal a Congressionally passed law. The splinter group disregards these mandated ways. There are two actions of Congress that could be repealed, which are 1 Statute 50 itself from 1789, or the implementation of 1 Statute 50 in 2016. The Constitution states that Congress can sponsor a bill to do this, through the lawful legislative process, or a formal review can be requested through the Supreme Court. There is no option to destroy the lawful Republic in order to remove the law. (*Marbury v. Madison*, 5 U.S. 137, 1803). (Public Notice RR950286760RUSA – Lawful, Historical, and Constitutional Validation of the Republic for the United States of America.)

4. Financial Integrity

SG Anon then claims financial impropriety without basis. In summary:

- Americans for Republic Foundation (AFRF): This private ministry was created by President Geiger and Secretary of the Treasury Kelby Smith. It accepts contributions outside IRS jurisdiction while maintaining independent financial records and reporting only to its internal leadership. Privacy in financial matters is essential and is upheld as part of its operational structure (State of the Union, 2025). As the Republic currently is operating on an interim basis (without a Treasury), a third-party structure had to be set up for the People of the Republic through which contributions could be made. This ministry status ensures privacy for donors. Donations have not historically covered expenses (websites, online storage, email, conference calling, bulletin services, etc.), and Republic leaders, including Geiger, Smith, Miarecki, Hertler and others, have continued to fund shortfalls.
- God's Will Be Done Ministry (Turner Donations): A distinct fund was created to aid Turner while in prison, supported mainly by leadership contributions. In addition, HIS Advocates sent out email campaigns to its members on more than one occasion to support Turner.
- HIS Advocates S.S.M. (Self-Supported Ministry): For over 14 years, HIS Advocates has operated with an impeccable reputation, maintaining a complaint-free record with the Better Business Bureau. Founded by Kelby Smith in 2012, HIS Advocates was established as a separate ministry dedicated to assisting individuals in the complex process of disengaging from adhesion contracts with state and federal public franchises (governmental agencies). Due to the inherent conflict of interest, the Republic for the United States of America could not assume the responsibility of guiding individuals in their transition to State of the Union Citizenship. This intricate and demanding process necessitates significant support and expertise. For an in-depth overview, refer to the process outlined in: Living in the Private Program Diagram. HIS Advocates and the Americans for Republic Foundation share the same mailbox address through a UPS Store, which provides mail reception services for multiple businesses and foundations. The notion that two entities cannot share a mailing address is baseless.

Refuting False Narratives

SG Anon's podcast distorts key historical and lawful truths, as argued by many historians:

1. Treaty of Paris (1783): SG Anon claims that the treaty sabotaged the Articles of Confederation via British-aligned signatories. In reality, the treaty secured independence, with debt clauses (Articles 4–5) reflecting diplomatic norms, not conspiracy (*The Creation of the American Republic*, Gordon Wood). SG Anon's perspective suggests that the treaty's language and implementation forced a shift toward federalism, ultimately leading to the replacement of the Articles by the Constitution in 1789. While this might be an item for future debate, it has no impact on what the American People accomplished in re-inhabiting the original Constitutional Republic gifted to us by our Forefathers. In Utah in 2010, the Continental Congress of the American People decided that the Constitution for the United States is and will remain the Supreme Law of the Land.

- 2. Civil War and 1871 Act: SG Anon alleges a corporate overthrow, omitting the fact that Lincoln's actions actually preserved the Union. We concur that banking interests usurped the Republic starting around 1871, creating the UNITED STATES Corporation (defined under 28 U.S.C. § 3002(15)(A)) as a federal entity. This corporation operates under commercial law, not the Constitution, subverting the People's unalienable rights by following corporate bylaws, and ignoring the People.
- **3. 2010 Founding**: No evidence exists to support military backing of Turner nor General Dempsey's involvement beyond Turner's assertions. The Republic's re-inhabitation was civilian-led through a grassroots approach (<u>DSI</u>). The Re-inhabited books (especially Volume 2) go into detailed and heavily referenced accounts of just how this occurred.
- **4. Research provided to SG Anon:** On March 7 and 9, 2025, Sandy Miarecki provided SG Anon with a 30-page research paper (RR950286760RUSA) detailing the Republic's lawful standing. In addition, a March 9 evening phone call was held with SG Anon, Geiger, Hertler, and Miarecki, including email outreach for any future questions. Yet, within 24 hours of that call, SG Anon recorded his video. In addition, Hertler wrote a detailed summary of facts to answer one of SG Anon's questions from the phone call. This information was sent in an email in the late evening of March 11th, before SG Anon posted the video on March 12th that he had recorded on March 10th. All of this information refuted most, if not all of SG Anon's statements in the video. See Attached Affidavit.

Conclusion

For over two centuries, George Washington's prophecy unfolded as our Republic was subverted into a corporate entity. The 2010 re-inhabitation of the original Republic reclaimed lawful governance, not as a rogue faction but as a grassroots constitutional interim, thus countering SG Anon's claims of illegitimacy or military overreach. The Legal Standing of Churches, Humanitarian Foundations and Ministries Outside Government Jurisdiction

Introduction

In the United States, churches and ministries that do not register with the STATE or the SECRETARY OF STATE operate outside the jurisdiction of the United States government and the Internal Revenue Service (IRS). This principle has been upheld by various Supreme Court rulings and legal precedents, affirming that religious institutions inherently possess the right to operate free from governmental interference.

Americans for Republic Foundation (AFRF)

The Americans for Republic Foundation (AFRF) is a private ministry founded by Pres Geiger and Kelby Smith. It accepts contributions outside IRS jurisdiction while maintaining independent financial records and reporting only to its internal leadership. Privacy in financial matters is essential and is upheld as part of its operational structure (#Kelby Smith Video, State of the Union, 2025). As the Republic currently is operating on an interim basis, a third-party structure had to be set up for the People of the Republic through which contributions could be made.

Per the Declaration of Independence, the Republic People are directly under the Elohim. The People created the Declaration of Independence for the listed reasons. They did not ask for permission, and they did not register the document with any STATE, or even the King of England. Hence the people had a Trust indenture that they are able to operate from and through. A Humanitarian Foundation is much like the Declaration, in that we do NOT seek permission to be outside of the jurisdiction of a corporation like the UNITED STATES or IRS. The UNITED STATES is a corporation, not to be confused with the united States of America.

Throughout the 20th century, many churches, businesses, and trusts were converted into state-recognized corporations such as S & C Corporations, 501(c)(3) registered churches, and registered trusts, thereby subjecting themselves to government oversight. However, historical legal principles reaffirm that churches inherently hold an exempt status without requiring governmental recognition.

Exempt Organizations Under Federal Law

According to Title 26 of the United States Code and Income Tax Regulations - June 26, 1977 Edition (Commerce Clearing House Section 1.511-2(ii), volume 1, pages 33, 471, 472), and "The Law of Tax-Exempt Organizations" by Bruce Hopkins (page 107), the term "church" includes a religious order or organization if:

- It is an integral part of a church.
- It engages in carrying out church functions, regardless of incorporation status.

The inclusion of "or otherwise" in the code explicitly confirms that incorporation is not a requirement for churches to maintain their tax-exempt status.

IRS Code and Church Exemptions

The Internal Revenue Code (IRC) provides explicit exemptions for churches and religious organizations, reinforcing their right to operate independently:

- 5. IRC 508(a): "New organizations must notify the Secretary that they are applying for recognition of 501(c)(3) status, EXCEPT as provided in Subsection (c)."
- 6. IRC 508(c)(1): "Exceptions mandatory exceptions subsection (a) shall not apply to: (A) Churches, their integrated auxiliaries, and conventions or associations of churches."

Thus, churches and their auxiliaries are not required to apply for 501(c)(3) recognition. The government has no lawful authority to require churches to petition for tax-exempt status, as churches are inherently exempt.

Additionally:

- IRC 6033(a): Religious organizations are exempt from filing tax returns.
- IRC 6033(a)(2)(A)(i): Exempts "churches, their integrated auxiliaries, and conventions or associations of churches" from filing requirements.

An "integrated auxiliary" is defined as a part of a whole, and an "auxiliary" is a part that assists another. Given that a church ministry operates as an auxiliary to the Church, it qualifies for exemption under these provisions.

Constitutional Protections and Supreme Court Rulings

The First Amendment of the U.S. Constitution explicitly states:

"Congress shall make NO LAW respecting an establishment of religion, or prohibiting the free exercise thereof."

This provision has been reaffirmed in multiple Supreme Court rulings (under the Corporation):

- Hale v. Henkel, 201 U.S. 43 (1906): Confirmed that private entities operating outside of governmental recognition are beyond the reach of regulatory oversight unless they voluntarily submit.
- Murdock v. Pennsylvania, 319 U.S. 105 (1943): Held that religious institutions cannot be compelled to register or pay fees to the government as a condition of their operation.
- Walz v. Tax Commission of the City of New York, 397 U.S. 664 (1970): Reinforced that tax exemptions for religious organizations do not violate the Establishment Clause but rather uphold religious liberty.
- **Zorach v. Clauson, 343 U.S. 306 (1952)**: Acknowledged that the government must accommodate and not hinder religious institutions in their mission.
- Holy Trinity Church v. United States, 143 U.S. 457 (1892): Established that the United States is founded on religious principles and that churches hold a unique, protected status under American law.

Conclusion

Churches, Humanitarian Foundations and Ministries (that are lawfully unregistered) are inherently exempt from government taxation and regulatory oversight, as confirmed by federal statutes and constitutional law. The U.S. Supreme Court has consistently ruled in favor of the People's right to operate religious institutions without interference. No law requires a church or ministry to register with the IRS or apply for tax-exempt status, and their exemption remains intact whether or not they file.

By exercising these rights, churches and religious organizations can maintain their autonomy, ensuring their operations remain outside governmental jurisdiction while fully compliant with constitutional protections.

Affidavit of Fact

Testimony of Fact as Relates to
Affiant's Groundwork with the Republic for the United States of America
and Wisconsin free State since December 2010

I, Jean Marie Hertler, the undersigned Affiant, make this Affidavit of Fact of my own free will and hereby affirm and declare under oath that I am of lawful age and of sound mind and hereby attest under pains and penalties of perjury that the information contained in this Affidavit bears witness to the Truth, is correct to the best of my knowledge, and is not misleading.

As the Affiant, I affirm my history of groundwork and positions held within the Republic for the United States of America from December 2010 to present and testify to my firsthand knowledge of recorded history pertaining to the lawful re-inhabitation of the Republic for the United States.

- Affiant signed a Declaration of Sovereign Rights on December 18, 2010, and again on April 9, 2011 in covenant affirmation declaring that Affiant affirms, publishes, and declares that I am absolved from all political allegiance foreign to these free and independent united States of America and with a firm reliance on Divine Providence Affiant pledged my life, fortune and sacred honor to our Republic.
- 2. On February 18, 2011 Affiant signed an Oath of Office for State Administrator of Wisconsin free State. On September 11, 2011, Affiant signed an Oath of Office for Wisconsin free State's office of Records Keeper, and on March 7, 2012, Affiant also assumed additional responsibility by signing an Oath of Office for Chief of Staff to the then Governor of Wisconsin free State.
- 3. On February 26, 2014, with the recommendation of Wisconsin free State then Acting Governor Dean Henning and receiving the unanimous consent of the legislative Senate, Affiant withdrew from other offices held and stepped forward as Secretary of State having been administered an Oath of Office by Wisconsin free State Chief Justice Michael Brum.
- 4. Affiant believes unreservedly that I was called by Almighty God to serve Him and His Republic for the United States of America. Affiant has demonstrated my belief through my dedicated work and unreserved effort to bring the American Republic to full restoration.

- 5. Affiant has lived absolutely surrendered in the call of Almighty God in serving Wisconsin free State and the Republic for the United States of America. Wherever a need was known, Affiant put her hand to the task and did whatever it found to do with a standard of excellence
 - Ecclesiastes 9:10 ~ Whatsoever thy hand findeth to do, do it with thy might; for there is no work, nor device, nor knowledge, nor wisdom, in the grave, whither thou goest.
 - Colossians 3:23-2 ~ And whatsoever ye do, do it heartily, as to the Lord, and not unto men; Knowing that of the Lord ye shall receive the reward of the inheritance: for ye serve the Lord Christ.
- 6. In 2013, Affiant came to the realization that I was appointed by Almighty God in ministering to reinhabiting President James Timothy Turner in his time of trial, unlawful incarceration along with considerable cruel and unusual punishment. This realization became apparent to me when no others in his circle of leaders were allowed by the powers-that-be of the *de facto* Corporate UNITED STATES to be in communication with him except Affiant, who was not at that level of national leadership or in his circle of leaders.
- 7. Since July 2013, Affiant received weekly telephone calls from President Turner in prison, had been in communication with him by email, handwritten letters, and created printed newsletters to keep him stay apprised of current events in true news. Affiant also stayed in regular communication with his wife and oftentimes helped them stay connected. Affiant's close relationship with Mr. Turner and his wife continued on a regular basis after his release from prison in May 2023.
- 8. In 2015, Affiant was directed by then Acting President James Geiger to manage the finances of the *God's Will Be Done Ministry* account on behalf of President Turner as well as managing disbursements for his monthly needs. Then Acting Secretary of State Jeanine Stewart, manager of the ministry account, instructed Affiant in all the managerial duties as well as assigning to Affiant the passwords to various related accounts.
- 9. Due to lack of donations and extenuating circumstances, Affiant resigned from *God's Will Be Done Ministry* managerial duties and continued in agreement with her husband to send personal funds on a monthly basis to sustain the unlawfully incarcerated and political prisoner former President Turner.

- 10. Affiant has demonstrated that she has the reverential awe and fear of the Lord and that she does not fear man. In 2012, when rogue elements and agent infiltrates moved to unlawfully remove then President Turner against his will while also seeking to take over the Republic for destruction, and when unsuccessful in their attempt to take it down, Affiant and husband were part of a small remnant that labored diligently for more than a decade to hold it together.
- 11. On at least four occasions, my husband David Hertler and I, along with other Wisconsin free State officers, met with *de facto* three-letter agents for various reasons and gave testimony to the reinhabited Republic while also disseminating true knowledge of American history with these *de facto* agents. Affiant received periodic telephone calls from two of about eight of these agents through the years leading up to the first *de facto* election of Donald J. Trump when contact from all three-letter agents halted. I would describe all of these communications to have been positive and question the character of only one agent in particular.
- 12. Affiant has a testimony in her calling of Almighty God due to profound circumstances that led to writing a legal brief for the Courts of Heaven that ended in birthing into the two volumes of *Reinhabited: Republic for the United States of America.* Volume I is entitled, "America's Truthful History" and Volume II is entitled, "The Story of the Re-inhabitation." This writing venture began as an official assignment by then Acting Secretary of State Jeanine Stewart to Affiant in the presence of the then Vice President in March 2014. Affiant's journals is pertinent information and a thorough history of interim government operations that is well documented. These journals have been archived as interim government records and include history of all three branches of government involvement specifically with relation to the Northwest Ordinance/1 Statute 50 process of building the free States toward restoration by learning and working toward while preparing for the time of permanent elections and turnkey of government operations to the fully restored American Republic.

14. On January 10, 2017, Affiant received a Presidential Appointment to the Republic Education Team which led to my eventual resignation from the office of Wisconsin free State Secretary of State. This direction aligned with logic in following the unprecedented and encompassing American history books I authored with my husband, David Hertler, as we together continued in bringing forth knowledge to the American people as to their God-given rights and civil duty as stated in our nation's Founding Document, the Declaration of Independence. Herein established is Affiant's foundation and groundwork with the Republic for the United States of America as well as having become the nation's scribe and historical archivist in the lawful re-inhabitation and restoration of the American Republic.

I, Jean Marie Hertler, the undersigned Affiant, make this Affidavit of Fact of my own free will and hereby affirm and declare under oath that I am of lawful age and of sound mind and hereby attest under pains and penalties of perjury that the information contained in this Affidavit bears witness to the Truth, is correct to the best of my knowledge, and is not misleading.

As the Affiant, I affirm my history and positions held within the Republic for the United States of America from December 2010 to present and testify to my firsthand knowledge of recorded history pertaining to the lawful re-inhabitation of the Republic for the United States of America. This subject matter pertains to email correspondence between SGAnon, Secretary of State Sandy Miarecki, and President James Geiger after a 4-way phone conversation held Sunday night, March 9, 2025. This subject matter also addresses historical knowledge and information provided to SGAnon before he recorded his March 10, 2025 video of which was published two days later on March 12, 2025.

- Affiant testifies to receiving an email addressed to myself, Secretary of State Sandy Miarecki, and President Geiger dated the evening of March 11, 2025 from SGAnon requesting assistance in locating and obtaining the Republic 2014-2016 Congressional records of which President Geiger had stated began the process of the implementation of 1 Statute 50. - 2. That night, in a responding email dated seconds after midnight on March 12, 2025, Affiant brought forth knowledge of historical facts and archived records of national leadership discussions and disseminating knowledge on the 1 Stat 50 process of "Building the States" had beginning on November 8, 2016 in Joint Sessions of Congress with a total of 9 sessions and the Judiciary of which joined Congress in the last 7 sessions beginning in January 2017. 

SG, in receiving your email this evening, I've spent some time in my files of Congress/Joint sessions with the House & Senate recordings that I have saved in my files beginning in 2014 on the topic of going forward with the Northwest Ordinance and 1 Stat 50 process. Hi Sister, I hope this email finds you and yours well and highly blessed by our Father in heaven. I am excited about the appeal to Heaven ceremony comming up. I believe that doors are going to open that no man can shut.. I will begin the fast of unleavened bread on Friday at sundown for seven days in honor of the Covenant. Our God is in control and has always been. I am not elligible to participate in Passover as I am not registered as Jewish. I met with the chaplain and he explained it to me. I explained to him that it was not important but i would be keeping Passover myself anyway. It would be great to spend it with you and your family. Maybe next year.
