

State of the Union Address

March 3rd 2025

We have arrived once again at another pivotal moment in the Republic. Infiltrators are attempting to convince patriotic officials and members of the Republic to do harm to the Republic according to a new destructive agenda. The agenda is almost identical to that of the first infiltration in 2012. Now you know why we wanted you to read the Re-Inhabited books, to learn about the first infiltration so that you would recognize it the next time. We will need to coin a new phrase to describe it. Let's call it a "Masonic / nation-state / county assembly agenda" that is quickly turning into a personality cult.

Its foundations are rooted in dishonorable conduct, envy, subterfuge, lies and false allegations. Whatever they try to establish will be built on these foundation stones. For those of you on the Wire chats, you have undoubtedly seen the attempt to sow discord using emotional accusations without basis or evidence, the exact strategy used in 2012 to harm the Republic when Tim Turner was president.

Historically, the first *de jure* Congress in 1789, during their first session, codified the Northwest Ordinance into a de jure law known as 1 Statute 50. The Republic that was re-inhabited in 2010 follows the exact same law-form.

Please understand that the decision to implement 1 Statute 50 came from careful study and deliberation by all three branches of government of the Republic for the united States of America, and this deliberation started during Tim Turner's administration. The house, senate and judiciary were convinced that the implementation of 1 Statute 50 was the proper way forward. By April 2014, the Senate had already been working on draft implementation. The bottom line is that the implementation of the Northwest Ordinance and 1 Statute 50 was precisely planned and executed by all of Republic leadership; including Tim Turner who was getting regular updates on all of these happenings while he was incarcerated.

The infiltrators claim that they do not recognize the Northwest Ordinance and 1 Statute 50, and yet this is the only authority for their appointment to hold office. In law, by denying the relevance of 1 Statute 50, they have voluntarily un-appointed themselves. They removed the only lawful connection for them to hold any Republic office. Not only is that an affront to the Republic for the united States of America, but it is also an affront to the framers of the Constitution.

One of the accusations of the infiltrators is that 1 Statute 50 doesn't apply because it was ratified in 1789, while the Constitution was fully ratified in 1791. However, Congress did not renumber itself. There wasn't a First Congress in 1789, and then another First Congress in 1791. So this accusation does not hold any water. 1 Statute 50 is a 100% valid law passed by Congress under the Constitution.

Let me speak clearly: neither myself nor anyone that I have appointed can pretend to represent the American People en masse. However, we do claim to be the interim officials in the original Republic that was re-inhabited by the American people in 2010, despite severe interference from the de facto corporation. We are the government for the American People, waiting for the People to want their Republic back. That is why we are re-seating the vacated states via the territorial and statehood process outlined by our Forefathers, in 1 Statute 50. You can do the deep dive by reading the recently posted Public Notice entitled Lawful, Historical, and Constitutional Validation of the Republic for the United States of America. If anyone, including Tim Turner, wishes to submit a document disputing the work of the Republic house, senate and judiciary, it will be lawfully evaluated.

Now let me address the resignation of Attorney General Tim Turner. Why would the current instigators of confusion and discord within the Republic stay at Tim's house for months on end? As Tim stated in his resignation letter, his health has been failing, and he no longer has the ability to deal with disputes within the Republic that an Attorney General would be expected to address. However, what Tim thought were "disputes" were actually attacks by infiltrators. Now we know that Tim is working with the infiltrators to destroy the current Republic and start a new Republic 2.0. This is supposedly what the "white hat military" is telling Tim to do. But there is no chance that the "white hat military" would bypass the chain of command in the Republic to talk to Tim and violate their oaths of office. None. So who is actually talking to Tim Turner? Who would benefit from the destruction of this Republic? Regardless, we all need to keep Tim in our prayers, asking God to protect him from the infiltrators while he works to regain his health.

The infiltrators are stating that it is ok for previous Freemasons (including high ranking ones) to join the Republic. But how would that outcome be any different than what we have right now in America? The Masons are responsible for destroying the foundations of the Republic that our Forefathers created. If the Masons were allowed to continue their interference, then this Republic would have accomplished nothing. Therefore, I strongly recommend that each of the re-seated states, once they are able to convene a state constitutional convention, should incorporate language that bars members of secret societies from serving within the seats of government, or bars secret societies altogether.

While talking about the state constitutions, let's visit the original organic 13th Amendment passed in 1819, which deals with the penalties for titles of nobility. If you accept a title of nobility, such as Esquire for Bar attorneys, you lose your citizenship and you are forbidden from holding any office. There is no reason why this limitation could not be written into each of the free state constitutions today, and include wording about members of secret societies.

The strategies of the infiltrators back in 2012 are the same as the strategies today. For those that read the Re-inhabited books, you will recognize these strategies:

- (1) accuse the President and other Republic Leaders of misdeeds that never happened, and without evidence;
- (2) sow discord to divide and conquer the Republic by posting the baseless accusations in public chats;
- (3) attempt a takeover of the Republic Senate by declaring a social Senate meeting is the actual official Senate (without Senior Senate leadership present);
- (4) declare the social Senate meeting has an official quorum while having only 10 appointed Senators present. A minimum of 67 Senators out of 100 is needed for a functional quorum;
- (5) unlawfully vote in a Senate President without a quorum and without following the Standing Rules of the Senate for having such a vote;
- (6) create a splinter governors' group openly discussing how to bypass and circumvent the lawful Republic leadership; and
- (7) do all this while still under oath to the Constitution and their promise to honorably perform their duties to support the Republic.

Obviously none of this can and should be tolerated. This is not a social club, this is the lawful interim government of the Republic for the united States America.

Because of the actions listed above, I commissioned a committee of trusted senior officials to look into the matter and provide me with their recommendations for courses of action. This has resulted in the revocation of appointments (as of the end of February), due to loss of confidence in their abilities, for 7 governors, 13 Senators, and 2 Secretaries of State, For those that had not yet been appointed, the actions above have also resulted in the vetting committee rejecting their candidacy. A few more officials have resigned because of the infiltrators. Acting in dishonor cannot be tolerated.

We need to emphasize that everyone in this Republic is a volunteer. If you don't agree with what this Republic stands for, then the honorable thing to do is to resign and leave in peace. Consider forming your own republic or whatever you choose. This is just like when you are looking for a new church. You don't go up to the pastor in the middle of services and demand that he preach the way you like. You simply go find another church that suits your beliefs.

In this Republic, when you accept your appointment through the Northwest Ordinance codified as 1 Statute 50, you accept everything that it stands for. The Republic's solemn promise to the American People, through the Declaration of Sovereign Intent and Proclamation of Claim and Interest, is irrevocable.
